- The school should ensure the strong governance and management of its activities in way of comprehensive and quantifiab in way of curriculum planning, infrastructure, resources, physical education, staff development and other co-curricular are 5.
- The school should go through the provision of Affiliation and Examination Bye Laws and keep a copy there of for repurpose and also advised to visit CBSE websites i.e. http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates. The Sch expected to see all circulars on these CBSE websites regularly.
- The school will strictly adhere to all rules regarding safety of students including Fire fighting and Transportation, etc. Furth 6.

For increase in D 9. sections, the School shall apply online to the Board as per rule 15.7 of Affiliation Bye laws.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust ( other identity related to running of school affiliated to CBSE. The school shall also be liable to bear all legal charges incurre 10.
- The school must strive to promote conservation of environment on their campus through rain water harvesting, segregation

- Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinatio the year mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing 14. 15.
- Running of coaching institutions in the school premises in the pretext of providing coaching to the students for various example. is not permitted by the Board. Strict action would be taken on defaulters.
- The Manger and the Principal of the school shall be jointly responsible for the authenticity of the online/offline documents/ information/data submitted by the School to the Board.
